#### The Leona A. Louis Memorial Scholarship

Jim Louis shared with us this information about how the Leona A. Louis Memorial Scholarship came into existence: While it was my father Arthur, who was a Conductor on the New York Central, and my brother Jerry, a Fireman on Conrail and UTU Local Chairman, who gave me my love of the railroad, it was my mother Leona who gave me the love of the union. My father passed away in 1968 when I was ten and my brother died at work in 1979.

My Mother was born in Flint, Michigan, in 1920, and followed her father and uncles into the trade as a baker at the age of 14. When she first attempted to join the bakers union she was denied membership due to her age and because she was female. After several attempts, she was finally allowed membership.

While my dad was at work, she would tell me stories about when she was baking bread during the sit-down strikes at GM in 1936-37. She would hide the loaves of bread and walk up by the fences and throw them to the workers in the plant. She would tell me how the police and guards would scream and run toward her in an attempt the stop the food from getting in. One of her

favorite sayings was: "If you have an issue, take it to the union hall and not to the locker room." Mom went on to raise 5 children and 13 foster children. She would take in the children of an entire family because she never wanted to see a family split up. She received her first pacemaker at age 48. She had a total of 9 in a span of 32 years. She would visit area hospitals as a member of The Mended Hearts, to reassure patients awaiting surgery. Mom passed away in 2001 at the age of 80. Janet and I wanted to do something in her honor to continue her legacy, so when we hosted the EUMA in 2004, we thought of the BLET Auxiliary and quietly started the donation with Mom in mind. When I saw one of the recipients a couple of years ago residing in Michigan, we knew we did the right thing.

#### **Happy News for Lindsay Loeb and Family!**

Remember the "Lots of Love for Lindsay" article in the Spring edition of this publication? Lindsay is the two-year-old daughter of Sue and Dan Loeb, a New Jersey Transit engineer. Lindsay spent seven months waiting for a new heart after her own heart was severely damaged by a condition known as dilated cardiomyopathy. During that time she was kept alive through the use of a Berlin Heart Machine. I am very excited to share the news that Lindsay received a heart transplant on June 12 and is doing well. The heart came to her from another little princess who was in the same pediatric unit as Lindsay. They had become familiar with the Loeb family when they saw them strolling around the unit with Lindsay in a wagon pulled by Dan, accompanied by a nurse pushing the heart machine, and a third person pulling Lindsay's IV pole. These were Lindsay's only opportunities to leave her hospital room. When the little girl's parents learned that Lindsay had been waiting more than six month's for a donor heart, and then they learned that their little daughter was not going to make it, they decided to have her heart donated to Lindsay.

Following the transplant, Lindsay went to a rehab hospital where she received numerous therapy sessions every day to regain her strength and teach her how to talk, eat, walk, and function as a normal two-year old again. On the weekend of August 25, Lindsay was able to leave the hospital for a visit to her home to attend the birthday party of her twin sisters, Abigail and Emily, who turned 9 on August 27.

The Lindsay family is eternally grateful to all who have helped them along the way of their journey with Lindsay. Dan says, "The support we've gotten from our Brother and Sister Engineers has been incredible." The numerous fundraisers and collections, and even a program for fellow engineers to donate sick leave days to Dan, have kept them afloat during this journey. Lindsay's projected discharge date from the rehab hospital is September 30. Please continue to keep Lindsay in your thoughts and prayers as she gets stronger and healthier. ### THUD Appropriations Bill Passed then Pulled

With support collapsing, a \$44.1 billion Transportation, Housing, and Urban Development (THUD) bill for 2014 funding that was passed by both the Senate and the House on June 27 was pulled abruptly from the House floor on July 31, with top Republicans conceding, it was a further sign that the party's budget strategy is unraveling.

Under the House bill, Amtrak funding would have been slashed by one-third and high performance rail grants eliminated. among other cuts. House Majority Leader Eric Cantor's office said the House will return to the bill in September, after the recess. But House Appropriations Committee Chairman Harold Rogers (R-KY) bluntly said the chances of resurrecting the measure are "bleak at best." He stated: "With this action, the House has declined to proceed on the implementation of the very budget it adopted three months ago. Thus I believe that the House has made its choice: sequestration—and its unrealistic and ill-conceived discretionary cuts—must be brought to an end." So, even if the Senate passes its bill, there won't be any clear path to make that bill into law.

On July 31, Senator Harry filed a motion to invoke cloture in order to end debate and bring the bill to the floor for a vote. The cloture vote failed to garner the required 60 votes and subsequently the entire bill was pulled from the floor.

As Congress returns to work on September 9, the debates over U.S. military involvement in Syria and federal government spending are crowding an already-packed congressional calendar. With the new fiscal year start date of October 1 fast approaching, Congress will need to pass a continuing resolution by the end of September in order to keep

the U.S. Department of Transportation open and transportation dollars flowing.

The all-too-numerous attempts to eliminate Amtrak service have shown that our work is more necessary than ever. So let's continue to keep the pressure on until the passenger rail system our country so desperately needs is fully funded and fully functional.

### BLET Testifies in Support of Amtrak and Positive Train Control

On June 27, at the same time that the House Appropriations Committee was voting on legislation for Fiscal Year 2014 that would slash Amtrak funding 29% from last year, BLET Vice President and National Legislative Representative John Tolman testified before Congress in support of long-term federal funding for Amtrak and the need to improve railroad safety through the implementation of Positive Train Control (PTC) and other safety measures. In his testimony before the House Subcommittee on Railroads, at a hearing entitled "National Rail Policy: Examining Goals, Objectives, and Responsibilities," Tolman reinforced the need for Amtrak's long-term funding and the continued need for cooperation between freight railroads and labor to provide stimulus to our industry and the economy. He further emphasized the need to do all this while making the critical strides necessary to enhance rail safety.

He also testified that the National Rail Plan should protect organized rail labor, stating that it is imperative for any National Rail Policy or Plan to protect the interests of the men and women who work on America's railroads.

With regard to PTC, Tolman stated that the implementation of this technology will save lives and the BLET strongly supports PTC on our nation's railroads. He chastised the rail industry for seeking an extension of the federally-mandated deadline of 2015 for installation of the life-saving technology. He stated: "This technology will prevent the most egregious and catastrophic accidents where hazardous materials or passenger trains are involved, protecting the public and railroad employees. PTC needs to move forward."

He further stressed the need for support of Amtrak and passenger rail, pointing

out the ridership records set by Amtrak in recent years in spite of being underfunded. Amtrak has moved ahead with providing a version of positive train control to help protect their employees and the public, some of which has been in place since 1996. He stated that, "Now is not the time to nickel and dime the system; now is the time to stimulate the economy and invest in jobs through the creation of a good rail passenger system throughout the nation. For every \$1 billion invested, such a program could create 47,000 good-paying, middle class jobs."

### Senate Confirms President Obama's Recess Appointments

Richard Cordray Appointment to Consumer Financial Protection Bureau Confirmed: On July 17, the Senate finally confirmed the appointment of Richard Cordray as the Director of Consumer Financial Protection Bureau (CFCB). As you may remember Mr. Cordray's appointment was one of several made by President Obama on January 4, 2012, under the Recess Appointment Clause of the U.S. Constitution. The President also appointed three new members to the vacant positions on the National Labor Relations Board on that same date. Until last month, none of these appointments had been confirmed by the Senate.

The vote to confirm Cordray's appointment had been blocked by Republicans for almost two years in an attempt to weaken the Dodd-Frank Wall Street Reform and Consumer Protection Act, which is the law that established the CFPB and charged the agency to regulate and protect consumers' financial products from student loans, to mortgages, to credit cards. GOP politicians contended that the CFPB had too much power and sought changes including yearly Congressional approval of the agency's budget and the replacement of its director with a board.

In explaining why 12 Republican senators finally joined 54 Democrats to approve

Mr. Cordray's appointment, Senator Bob Corker (R-TN), told The Wall Street Journal that some Republicans had realized that "maybe" it wasn't right to hold up a qualified nominee because you don't like the law.

The CFPB was first proposed by Massachusetts Senator Elizabeth Warren in 2007 in an article that appeared in Democracy: A Journal of Ideas. The Board was then created in 2011 following the passage of the Dodd-Frank Act, which was passed as a response to the financial crisis of 2007–08. The creation of this agency stands as one of the biggest and clearest victories yet won in the struggle for fundamental reform of the financial system. In its short life, the CFPB has already:

- Moved to rid the mortgage market of loans designed to self-destruct.
- Shielded military families against various financial scams.
- Warned auto lenders against practices that jack up the price of credit for African-Americans, Latinos, women, or seniors.
- Returned nearly half a billion dollars to consumers cheated by credit card companies.
- Begun to tackle a host of other problems, including predatory payday loans, excessive bank overdraft fees, abusive debt collection practices, and the plight of students and families trapped in high-cost private education loans.

Following Cordray's confirmation, Senator Warren stated: "The political stalemate is over; there is no doubt the consumer agency will survive beyond the crib."

#### National Labor Relations Board Appointments Confirmed

On July 30, the Senate voted to confirm all of the three appointments made by President Obama to the National Labor Relations Board on January 4, 2012. For the first time in nearly a decade, the NLRB will have five full members—three Democrats and two Republicans—all confirmed by the Senate. This vote removes the air of uncertainty that has plagued NLRB actions for some time. One effort that may particularly benefit from the confirmation of five full members is the rulemaking activity on the union election process, which the NLRB had previously left unfinished. The five NLRB members are Democrats Mark Pearce, Nancy Schiffer, and Kent Hirozawa, and Republicans Harry Johnson and Phil Miscimarra.

### Court Case on Recess AppointmentsStill Pending

The confirmation of these appointments, however, does not change the fact that the issue of President Obama's recess appointments is still moving through the court system. Earlier this year, a three-judge panel of the U.S. Court of Appeals in Washington, D.C., struck down those appointments, saying the U.S. Senate was not in recess at the time of the appointments. Similar rulings have followed, and the U.S. Supreme Court has announced it will hear arguments in the case.

### BLET Denounces One-Person Train Operations

On July 6, a runaway train on the Montreal, Maine and Atlantic Railway plowed through a small Quebec town, killing an estimated 50 people. That train was operated by a one-person crew—an engineer. Montreal, Maine and Atlantic Railway owns 510 miles of track in Maine, Vermont, and Quebec. It has a fleet of 26 locomotives and runs 15 trains daily, according to its website. This railroad has a long history of accidents in Canada, according to the Canadian Transportation Safety Board, which shows 129 accidents, including 77 derailments some of them minor—since 2003. The BLET represents train and engine service employees on the Montreal, Maine & Atlantic Short Line Railroad in the United States and has unsuccessfully fought the practice of using a one-person crew on this railroad since it began several years ago. Following this tragic accident, the BLET National issued a statement on July 19, 2013, in which BLET National President Dennis Pierce denounces one-person train operations and calls on "the White House, the Congress, and any regulatory body of the federal government with the authority to do so to take action to protect the safety of railroad operating crews and the public by putting an end, once and for all, to the inherently unsafe single-person operation of freight trains."

In August, the Brotherhood of Locomotive Engineers and Trainmen (BLET) and the Transportation Division of the Sheet Metal, Air, Rail and Transportation International Association (SMART) jointly filed legislation in Congress to require at least two crew members on all freight trains in the United States. Initial sponsors for the legislation, entitled the "Safe Freight Act,"

are Representatives Michael Michaud (D-ME) and Chellie Pingree (D-ME), and the bill is expected to be assigned to the House Transportation and Infrastructure ("T&I") Committee for consideration. BLET National President Dennis R. Pierce called on the House to take up the bill at its earliest opportunity. "We thank Representatives Michael Michaud (D-ME) and Chellie Pingree (D-ME) and urge more Representatives to join in support."

Please encourage your members of Congress to take action to protect the safety of railroad operating crews and the public by putting an end to the unsafe practice of single-person operation of freight trains.

### Court Ruling on Inward Facing Cameras in Locomotive Cabs

On July 25, the United States District Court in Shreveport, Louisiana, ruled that the decision by Kansas City Southern Railway (KCSR) to install two inward-facing cameras in the cabs of its locomotives (see May 2013 update at http://www.bletauxiliary.net/Legislative%20Update%20May%2013.htm) presents a "minor" dispute under the Railway Labor Act, thereby paving the way for the railroad to install the cameras immediately. Under the provisions of the Railway Labor Act, Unions are prevented from exercising self-help over minor disputes.

The court ruled that the Carrier had an arguable contractual justification for its actions based on: (1) the Carrier's existing use of stationary surveillance cameras in train yards and other locations, (2) inward-facing cameras in crew vans, and (3) procedures for monitoring and recording phone calls between train crew employees and crew management regarding reporting to work. The judge who authored the Opinion also held that it was "not frivolous to argue that the safety challenges posed by employees using personal electronic devices on the job necessitate the camera and review system proposed by KCSR."

Following the determination that the case was a "minor" dispute, the Unions argued for a "status quo" injunction pending resolution of the dispute before an arbitrator, but the judge denied that argument. She did, however, explain that "at the end of the day, the Unions may prevail regarding interpretation of the [Collective Bargaining Agreement]."

BLET National President Dennis Pierce expressed disappointment over both decisions and vowed that the Union would keep

up the fight and will continue to assist the KCSR General Chairmen in their struggle. He stated that the Union will do its utmost "to prove to an arbitrator that this outrageous intrusion in the lives of locomotive engineers and trainmen is well beyond what the contract allows KCSR to do."

Union Pacific (UP) is planning to join Kansas City Southern (KCS) in installing inward-facing cameras in its locomotives. The rail company asked a federal court last month to clarify its authority to install the cameras under existing agreements with labor unions. Although the cameras have audio recording capabilities, UP has stated that the audio will not be activated at this time. A federal court in Louisiana ruled in KCS's favor earlier this year that cameras can be installed without the possibility of a legal strike. The BLET continues to oppose this action, stating that it is an invasion of privacy.

#### New Website for Health & Welfare Benefits Information

A new website is available to eligible railroad employees and their dependents. This website, www.yourtracktohealth. com, replaces the Railroad Information Depot website. The information on this new website gives members information from key providers, such as Aetna, Highmark Blue Cross Blue Shield, United Healthcare, Express-Scripts, MetLife, and EyeMed. When you see the "Your Track to Health" brand used on communications and in materials, please pay attention as the information being provided is important in helping you and your dependents better understand and optimize your health and welfare benefits.

The "Your Track to Health" provides several new features, including: (1) Secure sign on, which allows eligible employees and their dependents who are enrolled in the health and welfare benefits to securely access and manage personal benefits information online; and (2) an e-mail registration and subscription center, which allows eligible employees and their dependents to opt-in to receive important benefits, enrollment and health/wellness information, alerts and updates via email. The subscription center is where you can update and manage your email communications preferences.
