

LEGISLATIVE UPDATE

The Days that Follow...

The end has finally come to what has been described by some as the biggest division of our country since the Civil War. Finally an end to debates that feel more like a reality TV show! Social media, with all of its promotion of the worst of each candidate, will hopefully calm down and people can go back to life as usual. Now is a time of adjustment to let the results sink in and figure out how to move forward under the new President and Republicandominated Congress.

It is a scary time for those of us who believe in the Union and want to see it prosper and grow. What about our hard-earned Railroad Retirement—will it still be there when we finally reach that milestone? Questions like this have to be weighing heavy, not just on my mind, but for all railroad families today. It's hard to trust a President who wants to "Make America Great Again," yet passes out election paraphernalia that is all made in other countries, who belittles women, makes excuses for not paying income tax, and treats his employees with no regard.

I hope that this election season we have not lost sight of the local political issues in our home states and counties. Making sure we all educate ourselves and do the homework to make the right decisions about the issues that affect us most directly is important and should never be pushed aside just because there was a storming battle for the office of President playing in the background. Massive change can be accomplished right here in our communities through our involvement and good voting decisions.

Lastly, I hope that we all involved our children, regardless of age, in the importance of this election and explained to them the pros and cons of each candidate's plan for America and how it would affect us directly as railroad families. I felt confident I had done my part in this regard when my son called to be picked up early from school so he could be home for all of the election coverage. I know I sound like a broken record, but the future of this country is literally in the hands of the children we are raising. It's important that we take the time to educate them, involve them, and encourage them to participate, so they have a real understanding beyond what they hear at school. We must empower them to stand firm in their beliefs!

Increase in Railroad Retirement Benefits and Retiree Earning Cap for 2017

A cost of living raise for retirees is planned to go into effect in January 2017. Retirees should expect to see an increase of approximately \$6.00 a month, making the monthly benefit \$2628. Couples should expect to see an increase of \$9.00 per month, bringing their monthly income to \$3815.

Additionally, in 2017 the limit a retiree can earn is rising. For those under full retirement age throughout 2017, the exempt earnings amount rises from \$15,720 in 2016 to \$16,920 for 2017. For beneficiaries attaining full retirement age in 2017, the exempt earnings amount for the months before the month full retirement age is reached, rises from \$41,880 in 2016, to \$44,880 in 2017.

For those under full retirement age, the earnings deduction is \$1 in benefits for every \$2 of earnings over the exempt amount. For those attaining full retirement age in 2017, the deduction is \$1 for every \$3 of earnings over the exempt amount in the months before the month full retirement age is attained.

Texas High-Speed Rail Lawsuit

It seems as though not everyone is excited about the possibility of high-speed rail in the state of Texas between the cities of Houston and Dallas. The Waller County Sub-Regional Planning Commission filed a lawsuit against the Texas Department of Transportation (TxDOT) earlier this month.

The Waller County Planning

Commission claimed that the TxDOT is in violation of a Texas state law that says, "In carrying out their planning and program development responsibilities, state agencies shall, to the greatest extent feasible, coordinate planning with commissions to ensure efficient and orderly implementation of state programs at the regional level." However, the TxDOT issued a response saying they have been ordered by the Federal Railroad Administration (FRA) not to "participate in any coordination meetings."

"It is unfortunate it has come to this, but it became clear that the FRA, and now TxDOT, seem intent on keeping local governments such as Waller County and our municipalities completely out of the planning process. Without meaningful coordination, our community will suffer immediate and irreparable harm and that is totally unacceptable," Waller County Judge and WCSRPC President Trey Duhon said.

The TxDOT is the lead state agency working on the high-speed rail project. However, it is working under the oversight of the FRA. Both agencies are preparing an environmental impact statement that will address all impacts the new high-speed rail would have on local communities.

BLET Endorses TSB's Stand on Rail Fatigue

BLET National President Dennis Pierce endorsed the Transportation Safety Board of Canada (TSB) decision to include rail worker fatigue on their 2016 Safety Watchlist.

TSB Chair Kathy Fox recently said rail worker fatigue had been a factor in numerous investigations, most notably in freight rail operations. Fox stated: "Too many train crews aren't getting the rest they need, whether it's shifts that are too long or irregular scheduling that interferes with normal sleep times. . . . It's time for the railway industry to start applying fatigue science to crew scheduling, instead of calling for more studies."

NTSB Announces 2017-2018 Most Wanted List

The National Transportation and Safety Board (NTSB) has announced its 2017-2018 List of Most Wanted Transportation Safety Improvements. Since 1990, the NTSB has issued, its "Most Wanted List" to bring awareness and change to preventable accidents in the fields of aviation, rail, highway, marine, and pipeline, as well as hazardous materials. This year the rail industry finds itself in nine of the ten areas brought to attention.

Areas listed that relate directly to both passenger and freight rail include: (1) the implementation of positive train control (PTC); (2) ensuring safe shipment of hazardous materials in addition to proper emergency response training; (3) safety monitoring of transit rail to prevent problems that could ultimately cost lives; (4) the reduction of fatigue-related accidents; (5) requirement of more stringent medical guidelines for "safety-critical personnel;" and (6) the elimination of distractions so that crews are focused on the operation of their trains.

The NTSB also announced this year that they would begin issuing the list every two years rather than annually, stating "the change allows more time for the transportation industry, safety advocates, regulatory agencies, and individuals to effect the changes necessary to address the ten issues on the Most Wanted List."

Brussels Attacks Increased Security for US rail stations

In March of this year, suicide bombers attacked a Brussels metro station and airport, killing 32 people and injuring 300. In September of this year, a pipe bomb was found near a rail station in New Jersey. These acts, in addition to other terrorist threats around the world, have prompted a bipartisan group of senators to introduce a bill that would require the Transportation Security Administration (TSA) to increase security for surface transportation at both rail yards and ports around the U.S. The "Surface Transportation and Maritime Security Act" would bring to attention areas of concern in the TSA's battle to protect rail, transit, highway, and maritime passengers, and freight transportation.

"TSA has broad responsibilities for transportation security, but oversight and independent audits have raised considerable concern about its approach to protecting rail, transit, maritime, and highway travelers," said Senator John Thune (R-S.D.). "This bipartisan legislation addresses gaps in TSA's approach to assessing security risks and will help the agency better fulfill its role as a hub of analysis, planning, and information."

The bill would require the TSA to:

- Immediately increase canine teams patrolling train stations and ports, as well as enhance screening of rail passengers and maritime workers;
- conduct a risk analysis and implement a risk-based security model for surface transportation facilities;
- submit budgets that clearly indicate which resources will be used for surface transportation security and which will be used for aviation; and
- update Congress on the status of "long overdue" surface transportation rulemakings.

Rail Labor Seeks Mediation to Settle National Contract Talks

The following is from a BLET News Release dated 12-5-16:

Rail Labor's Coordinated Bargaining Group (CBG) released the following statement on December 5, 2016:

Despite our best efforts, collective bargaining with the major U.S. Class 1 railroads completely stalled late last week. Therefore, pursuant to the terms and conditions of the Railway Labor Act, we have today applied to the National Mediation Board (NMB) for the assignment of a federal mediator to assist in our negotiations.

This development is very disappointing, as the Unions in the Coordinated Bargaining Group have been at the negotiating table for almost two years seeking a voluntary settlement. Throughout that time, the Unions have steadfastly maintained that the Carriers' original demands were

unacceptable to our bargaining team, and would be found equally unacceptable by our collective membership.

Nevertheless, the Unions went to the table last week with the intention of reaching a satisfactory voluntary settlement that would fairly address the needs of both sides, but that did not happen. Unfortunately, the railroads apparently believe that the national elections in November have tipped the labor-management balance in this country heavily in their favor, as they made clear that no reasonable and fair resolution is any longer in the offing.

Our members have earned, and rightfully expect, a fair contract settlement that recognizes the fact that the industry continues to reap many billions in net profits annually. We have maintained from the outset that there is no reason not to bring these negotiations to a timely and equitable conclusion.

Instead, the railroads continue to demand extreme concessions that would erode our members' standard of living and earned benefits. We cautiously anticipate that the involvement of the NMB will cause the industry to refocus on addressing the legitimate needs of the men and women whose labor generates their positive financial returns.

Tax Withholding and Railroad Retirement Payments

The following information is excerpted from Railroad Retirement Form TXB-25 (01-2016), <u>www.rrb.gov/forms/PandS/tax/txb25.asp#</u>

Regular railroad retirement annuities consisting of tier 1, tier 2, and vested dual benefit components, have been subject to United States Federal income tax since 1984. Supplemental annuities have been subject to Federal income tax since 1966.

Taxable as a Social Security Benefit

The portion of the tier 1 component of a railroad retirement annuity that is equivalent to what the Social Security Administration would pay if railroad service were covered under the Social Security Act is treated the same as a Social Security benefit for Federal income tax purposes. Special guaranty amounts paid to some railroad retirement beneficiaries are also treated like Social Security benefits for Federal income tax purposes. The portions of a railroad retirement annuity that are taxable the same as Social Security benefits are generally referred to as social security equivalent benefits (SSEB).

To find out whether any of your social security equivalent benefits are taxable, you must compare the base amount for your filing status with the total of:

- All your taxable income, including taxable pensions, wages, interest, and dividends,
- Your tax-exempt interest income, and
- One-half of your social security equivalent benefits.

Your base amount is:

- \$25,000 if you are single, head of household, or qualifying widow(er),
- \$25,000 if you are married filing separately and lived apart from your spouse at all times during the year,
- \$32,000 if you are married filing jointly,
- \$ -0- if you are married filing separately and lived with your spouse at any time during the year.

If your taxable income and tax-exempt interest income, plus one-half of the amount of your social security equivalent benefits, is more than your base amount, some of your benefits may be taxable.

You can choose to have taxes withheld from the SSEB portion of your railroad retirement annuity by filing IRS Form W-4V. File the completed form at any Railroad Retirement Board (RRB) office. Forms W-4V are available at any IRS offices. The RRB will not withhold taxes from the SSEB portion of your annuity unless you file IRS Form W-4V.

Taxes on the Non-Social Security Equivalent Benefit Portion of Tier 1, Tier 2 Benefits, Vested Dual Benefits, and Supplemental Annuity Payments

The non-social security equivalent benefit (NSSEB) portion of tier 1 benefits, tier 2 benefits, vested dual benefits, and supplemental annuity payments are considered taxable income regardless of the amount of any other income you may have. These portions of your annuity are subject to Federal income tax withholding. If you file Form RRB W-4P to have taxes withheld based on your marital status and tax withholding allowances, we will withhold taxes from these portions of your annuity. We will not withhold taxes from the SSEB portion of your annuity unless you also file IRS Form W-4V.

Railroad retirement annuities are not taxable by states in accordance with section 14 of the Railroad Retirement Act (45 U.S.C. § 231m). The RRB will not withhold state income taxes from railroad retirement payments.

Purpose of Form RRB W- 4P

Form RRB W-4P is used by United States citizens or legal residents for U.S. tax purposes. Complete Form RRB W-4P to request:

- no Federal taxes be withheld from your railroad retirement payments,
- Federal taxes be withheld based on the marital status and the number of

- allowances you want to claim, or
- an additional amount be withheld from your railroad retirement payments.

If you live outside the 50 states or Washington D.C., Guam, and the Northern Mariana Islands, see the Note in the following section.

You are not required to file a Form RRB W- 4P. However, if you do not file and your combined taxable NSSEB, tier 2, vested dual benefit, and supplemental annuity components of your monthly railroad retirement annuity exceed \$1730.50 we will automatically withhold taxes as if you were married and claiming three allowances.

File Form RRB W- 4P no earlier than 6 months before the date your annuity is subject to tax withholding. We will adjust your withholding according to your RRB W- 4P request. Your request remains in effect until you change or cancel it with a new Form RRB W- 4P. You may file a new Form RRB W- 4P at any time. The adjustment to your payment will serve as notification that your request is in effect.

How to Complete Form RRB W-4P

Complete items 1 through 6 and item 11. If you answer "Yes" to item 6, also complete items 7 through 10, as appropriate.

Item 1, RRB Claim Number, and Item 3, Your Social Security Number: Be sure to provide your RRB Claim Number and your Social Security Number.

Item 6, Withholding or No Withholding Election:

Answer "Yes" if you want Federal income tax withheld from your railroad retirement payments.

Answer "NO" if you do not want Federal income tax withheld from your railroad retirement payments. If you answer "NO" to item 6, remember that having no tax withheld from your annuity payments does not reduce the amount of the taxes you may owe. There

are penalties for not paying enough tax during the year, either by tax withholding or by estimated tax payments. Internal Revenue Service Publication 505, Tax Withholding and Estimated Tax, explains estimated tax payments and penalties in detail.

We may <u>not</u> accept a "No" tax withholding election on Form RRB W-4P if:

- The individuals' United States social security number is not provided on the form or
- The individual resides outside the 50 United States, Washington D.C., Guam and the Commonwealth of the Northern Mariana Islands. If the "No" box is completed, the RRB will withhold taxes as if married and claiming three allowances.

Item 7, Marital Status: Enter your marital status for tax withholding purposes.

Item 8, Withholding Allowance:

Enter the number of withholding allowances you claimed in item 8. Use the worksheets on pages 5 and 6 to figure the number of your allowances. Generally, the more allowances you claim, the less tax is withheld. If you have more than one pension or annuity or if your spouse also has a pension or annuity, you may claim all of your allowances on one Form RRB W-4P or you may claim some on each Form RRB W-4P, but you may NOT claim the same allowances more than once. Your withholding will usually be more accurate if you claim all allowances on the Form RRB W-4P for the largest payment and claim zero on all other Forms RRB W-4P.

Note: The worksheets are only guides. They will give only approximate withholding allowance information.

Item 9, Additional Dollar Amount withheld from Annuity payments:

Answer "Yes" if you want an additional dollar amount withheld from your monthly benefits. This additional amount, which is computed on line 1 of the Multiple Pensions/More Than One Income Worksheet on page 6 will be added to any tax withholding amount computed based on the marital status and number of allowances you have entered in items 7 and 8 of Form RRB W- 4P.

If you do not want an additional dollar amount withheld from each payment, fill in the "NO" box and go to item 11.

Item 10, Additional Dollar Withholding Amount:

Enter the additional dollar amount you want withheld from each annuity payment. This includes all accrual payments regardless of the amount of the accrual. Use the amount from line 1 of the Multiple Pensions/More Than One Income Worksheet on page 6. Show whole dollars. Do not show cents.

Item 11, Signature and Date

The form must be signed to be valid. It should be signed and dated by the person who is responsible for signing any U.S. income tax return filed on the social security number entered in item 3.

Accrual Payments

Each payment you receive will be taxed based on what you claim on your RRB W- 4P. This includes accrual payments. If what you claimed on your RRB W-4P along with item 10 (additional amount) is more than the accrual payment we will also withhold the entire accrual payment. Even, if the tax withholding amount calculated is more than the accrual payment, we cannot withhold any portion of your SSEB, unless IRS Form W- 4V is filed with the RRB.

Statement of Annuity Payments and Taxes Withheld

No later than January 31 following the tax year, you will receive a statement showing the total annuity payments made to you during the preceding calendar year. This statement also shows the total amount of any taxes withheld from your payments. Use this statement to complete any income tax return you must file with the Internal Revenue Service for the tax year.

Tax Refunds

You may request a refund of any excess taxes withheld by filing an income tax return with the Internal Revenue Service after the end of the tax year. If you decide that too much tax is being withheld from your railroad retirement benefits, you can request a change in your withholding by filing a new Form RRB W- 4P and/or Form W-4V.

For Further Information, contact the nearest office of the Internal Revenue Service if you need more information about taxation, tax withholding, your personal tax obligations, or if you need help completing Form RRB W- 4P. Contact the nearest office of the RRB for any information you need about your railroad retirement payments.
